4. Origin

The former text:

4.1. Participation in this competitive negotiated procedure is open only to the invited companies (as identified in the List of Invited Companies in Part C of this tender dossier). Invited providers may form consortia only with other than invited companies provided that such a consortium will be led by the company identified in the above mentioned List of the Invited Companies. Possible members of the Consortium shall be the legal persons which are established in a Member State of the European Union or in a country or territory of the region covered and/or authorised by the specific instruments applicable to the programme under which the contract financed. (see item 22 below and http://ec.europa.eu/europeaid/work/procedures/implementation/eligibility/index_en.htm ; and go to Instrument for Pre-Accession Assistance (Council regulation (EC) No 1085/2006- OJ L210/82 of 31.7.2006). All goods supplied under this contract must originate in one or more of these countries. Participation as a consortium member is also open to international organisations. Participation of natural persons as a consortium member is directly governed by the specific instruments applicable to the programme under which the contract is financed.

Should read as new text:

4.1 Unless otherwise provided in the contract and/or authorised supplies must originate in a Member State of the European Community or an a country authorised by the specific instrument applicable to the IPA programme under which the contract is financed (http://ec.europa.eu/europeaid/work/procedures/implementation/eligibility/index_en.htm; next enter **GENERAL ANNEX A2** Eligibility programmes 2007-2013 and go to **Instrument for Pre-Accession Assistance (Council Regulation (EC) N° 1085/2006 - OJ L 210/82 of 31.7.2006)**. The origin of the goods must be determined according to the Community Customs Code or the international agreements to which the country concerned is a signatory.

Article 10.3, page 4 shall read:

All tenders must be received at the above mentioned address before the deadline date and time, **Thursday, 23th September 2010, 14:00 CET**, by registered letter with acknowledgement of receipt or hand delivered against receipt by signed by a representative of the Delegation of the EU to Bosnia and Herzegovina representative.

Article 19.2, page 7 shall read:

The tenders will be opened in public session on **Thursday 23th September 15:00 CET** at EU Delegation to Bosnia and Hercegovina, Skenderija 3a, 71000, Sarajevo, by the committee appointed for the purpose. The committee will draw up minutes of the meeting, which will be available on request.

All other terms and conditions of the Procurement Notice and Instruction to tenderers remain unchanged. The above alterations and or/corrections to the Procurement Notice and Instruction to Tenderers are integral part of the Procurement Notice.
