Corrigendum No. 1 to Procurement Notice

Technical assistance to successful NGOs from the anti-corruption grant scheme 2009

The following alterations and/ or corrections are made to the Procurement Notice:

4. Financing

Wording "Financing agreement" is deleted and replaced with the following wording:

Budget line: BGUE-B2010-22.020200-C8-ELARG DELBIH

21 Selection criteria, point 3) Technical capacity of candidate

Point 3) *Technical capacity of candidate* is deleted and replaced with the following wording:

3) Technical capacity of candidate:

1. Candidates have implemented at least 1 major project (minimum 200 000 EUR per project implemented by the candidate) in at least one of the fields related to this contract: **analysis of CSOs' capacities to combat corruption; or capacity building of CSOs on anti-corruption issues/measures; or capacity building of public institutions on anti-corruption issues/measures; or delivering training on anti-corruption issues to CSOs or public institutions** completed in the past 36 months prior to the launch of this tender.

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with them. It must in that case prove to the contracting authority that it will have at its disposal the resources necessary for performance of the contract, for example by producing an undertaking on the part of those entities to place those resources at its disposal. Such entities, for instance the parent company of the economic operator, must respect the same rules of eligibility and notably that of nationality, as the economic operator.

If more than 8 eligible candidates meet the above selection criteria, the relative strengths and weaknesses of the applications of these candidates must be re-examined to identify the 8 best applications for the tender procedure. The only factors which will be taken into consideration during this re-examination are:

- 1) The number of the completed relevant projects in the fields related to contract as per criterion 3.1 above;
- 2) The total financial value of the completed projects in fields related to this contract as per criterion 3.1 above.

The following wording is added:
