CORRIGENDUM No.1 to the Supply Contract Notice

EU supplies support to strengthening capacities of Food safety, Veterinary and Phytosanitary sectors in Bosnia and Herzegovina, EuropeAid/140726/DH/SUP/BA, EC/BiH/TEN/20/003

The following changes are made to the Contract Notice:

Point 16. Selection criteria, 3) *Technical capacity of tenderer*, is corrected as follows:

The text:

- 3) Technical capacity of tenderer (based on i.a. items 5 and 6 of the tender form for a supply contract). The reference period which will be taken into account will be the last three years preceding the submission deadline.

The selection criterion for each tenderer is as follows:

- For each Lot: the tenderer has delivered supplies under at least one contract with a budget of at least its financial offer in the field related to the Lot offered which was implemented during the following period: 28/09/2017 – 28/09/2020.

This means that the contract the tenderer refers to could have been started or completed at any time during the indicated period but it does not necessarily have to be started and completed during that period, nor implemented during the entire period. Tenderers are allowed to refer either to projects completed within the reference period (although started earlier) or to projects not yet completed. In the first case the project will be considered in its whole if proper evidence of performance is provided (statement or certificate from the entity which awarded the contract, final acceptance). In case of projects still on-going only the portion satisfactorily completed during the reference period will be taken into consideration. This portion will have to be supported by documentary evidence (similarly to projects completed) also detailing its value.

- 3) Technical capacity of tenderer (based on i.a. items 5 and 6 of the tender form for a supply contract). The reference period which will be taken into account will be the last three years preceding the submission deadline.

The selection criterion for each tenderer is as follows:

- **For Lot 1:** the tenderer has delivered supplies under at least:

EITHER

- a) one contract in the field related to both: provision of ICT equipment and development of software, provided that ICT equipment had a value corresponding to at least 50% of its financial offer for Lot 1 and that development of software had a value corresponding to at least 30% of its financial offer for Lot 1,

OR

- b) two contracts: one contract with a budget of at least 50% of its financial offer for Lot 1 in the field of provision of ICT equipment and one contract with a budget of at least 30% of its financial offer for Lot 1 in the field of software development.

All the above contracts (under a) and b)) must have been implemented during the following period: **04/10/2017 – 04/10/2020**.

- **For lots 2, 3, 4, 5 and 6:** the tenderer has delivered supplies under at least one contract with a budget of at least its financial offer in the field related to the Lot offered which was implemented during the following period: **04/10/2017 – 04/10/2020**.

This means that the contract the tenderer refers to could have been started or completed at any time during the indicated period but it does not necessarily have to be started and completed during that period, nor implemented during the entire period. Tenderers are allowed to refer either to projects completed within the reference period (although started earlier) or to projects not yet completed. In the first case the project will be considered in its whole if proper evidence of performance is provided (statement or certificate from the entity which awarded the contract, final acceptance). In case of projects still on-going only the portion satisfactorily completed during the reference period will be taken into consideration. This portion will have to be supported by documentary evidence (similarly to projects completed) also detailing its value.

All other terms and conditions of the Contract Notice remain unchanged. The above changes to the Contract Notice are integral part of the Contract Notice.
